Commissioner LaMarca,

At the previous Galt Mile Community Association meeting, the USACE representatives provided two timelines – one with an amicable agency resolution and the second with issuance of a 3c letter, which added an additional two weeks onto the schedule. After giving National Marine Fisheries Service (NMFS) an extended week of opportunity for resolution, the Corps was unable to negotiate with NMFS and issued a 3c letter on February 20th. This requires NMFS to rescind or elevate their objections by March 9, and based upon conversations, they do not intend on elevating their objection. Once rescinded, the Corps has stated they can issue a permit by end of week (March 13). As soon as we receive final resolution, we will inform you.
