BACKGROUND/DETAIL:

Herbal Incense products are presently being sold legally to minors and young adults, in convenience stores in gas stations in our city. These substances are unregulated and contain unknown chemical compounds, which pose a potential threat to the health and welfare of the individuals consuming these products. There are several documented incidents that have drawn a concern to members of the community. Presently these substances are incapable of being tested to determine if the compounds contained therein are of an illegal nature. The Police Department is proposing an ordinance banning the sale and distribution of Herbal Incense products containing synthetic cannabinoids.
