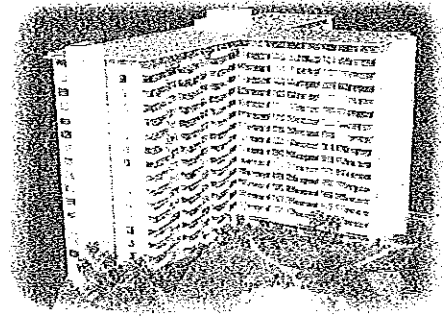


Dear Shareholder:
