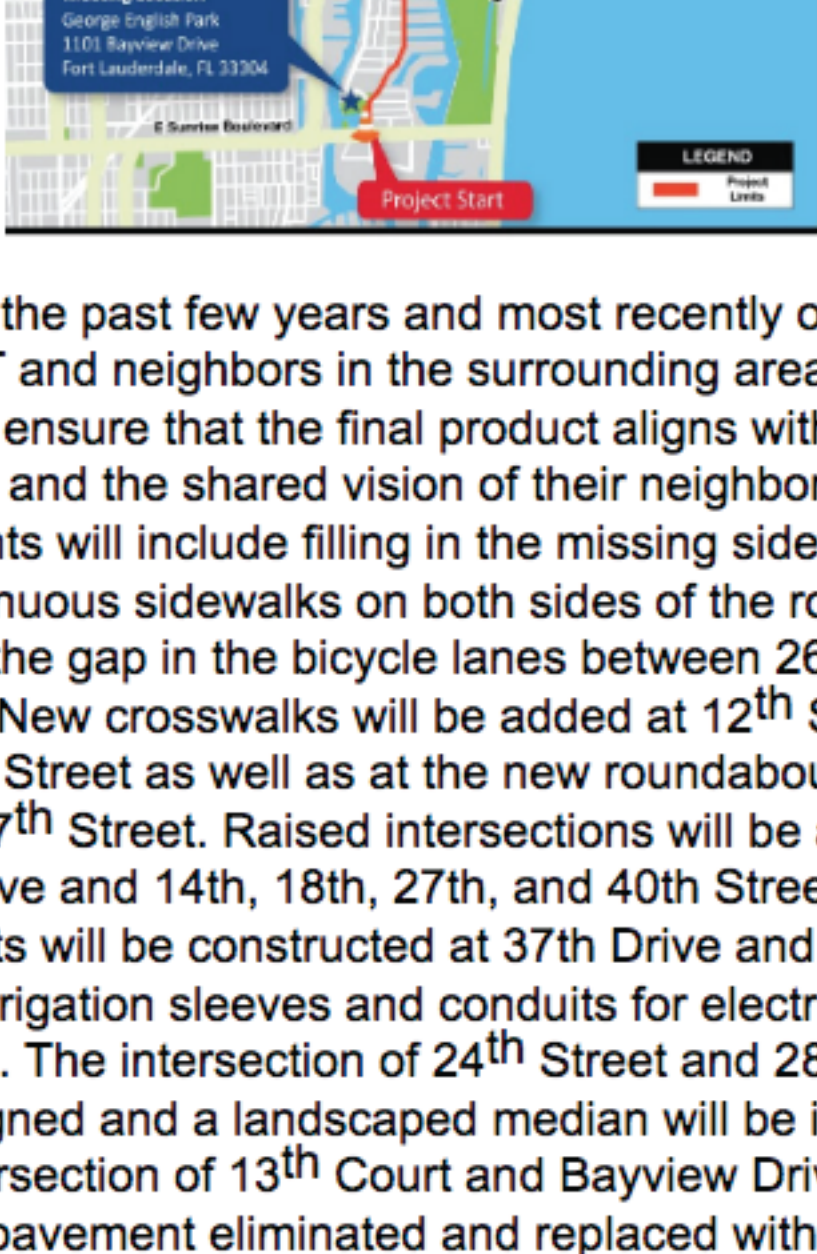
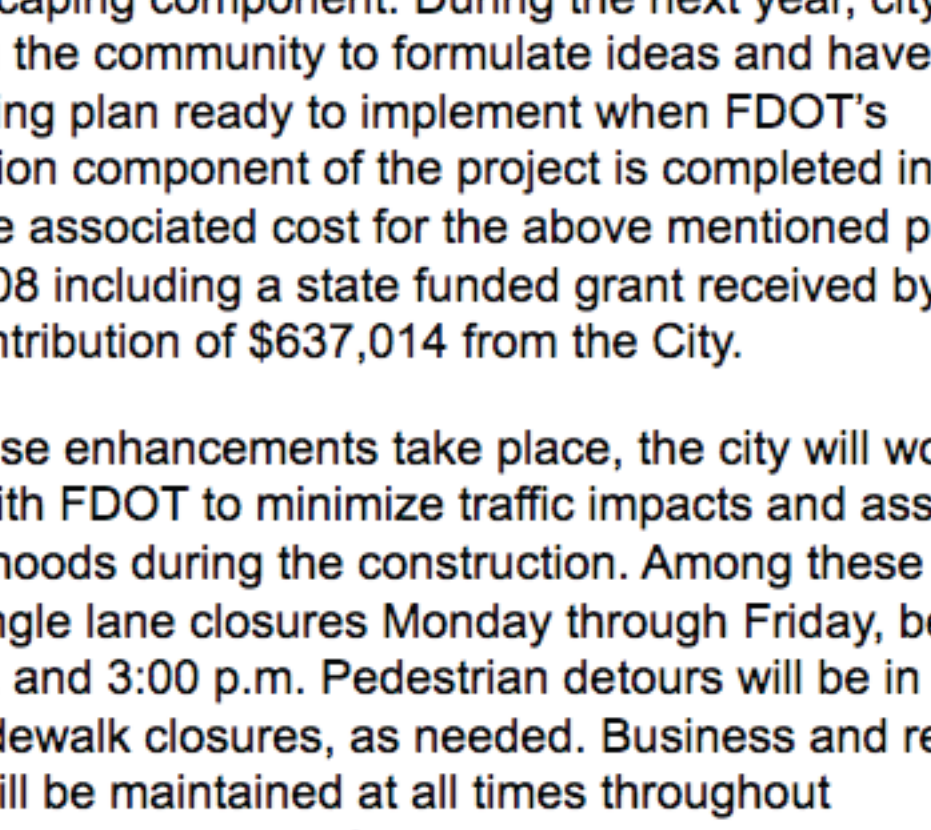


Construction for the Bayview Drive Mobility Project will now begin earlier than anticipated on April 27, 2022 and will continue into early 2023! These changes to Bayview Drive will provide an enhanced experience for residents in terms of functionality and overall appearance. There will be new access for walking and biking, along with the design providing traffic calming on Bayview Drive between Sunrise Blvd and Commercial Blvd!



Throughout the past few years and most recently on April 25th, 2022, FDOT and neighbors in the surrounding areas have held meetings to ensure that the final product aligns with the safety, functionality and the shared vision of their neighborhoods. The improvements will include filling in the missing sidewalks to create continuous sidewalks on both sides of the road and completing the gap in the bicycle lanes between 26th Street to 25th Place. New crosswalks will be added at 12th Street, 14th Street, 27th Street as well as at the new roundabouts at 37th Drive and 47th Street. Raised intersections will be added at Bayview Drive and 14th, 18th, 27th, and 40th Streets. Roundabouts will be constructed at 37th Drive and 47th Street along with irrigation sleeves and conduits for electric for future landscaping. The intersection of 24th Street and 28th Avenue will be realigned and a landscaped median will be installed, and the intersection of 13th Court and Bayview Drive will have the excess pavement eliminated and replaced with a landscaped island.



During the planning process, neighbors communicated a strong desire for FDOT and city staff to have landscaping planned in the roundabouts and other new roadway medians. Although FDOT will be constructing the actual roundabout, the implementation of landscaping within these structures is the responsibility of the city. When the construction aspect of this project is completed by FDOT, the city will then be able to add the landscaping component. During the next year, city staff will work with the community to formulate ideas and have a landscaping plan ready to implement when FDOT's construction component of the project is completed in early 2023. The associated cost for the above mentioned project is \$2,543,608 including a state funded grant received by the City and a contribution of \$637,014 from the City.

While these enhancements take place, the city will work closely with FDOT to minimize traffic impacts and assist the neighborhoods during the construction. Among these impacts will be single lane closures Monday through Friday, between 7:00 a.m. and 3:00 p.m. Pedestrian detours will be in place during sidewalk closures, as needed. Business and residential access will be maintained at all times throughout construction. 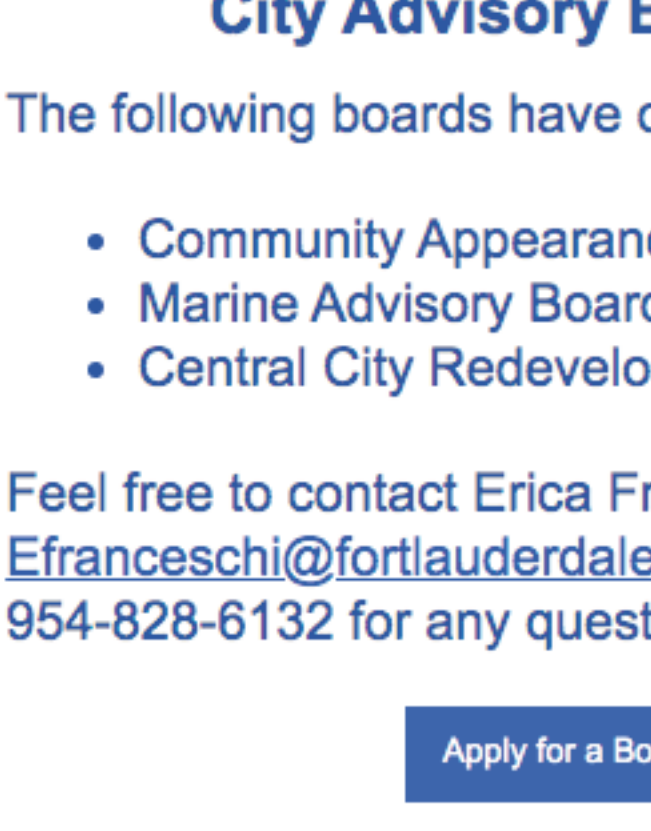

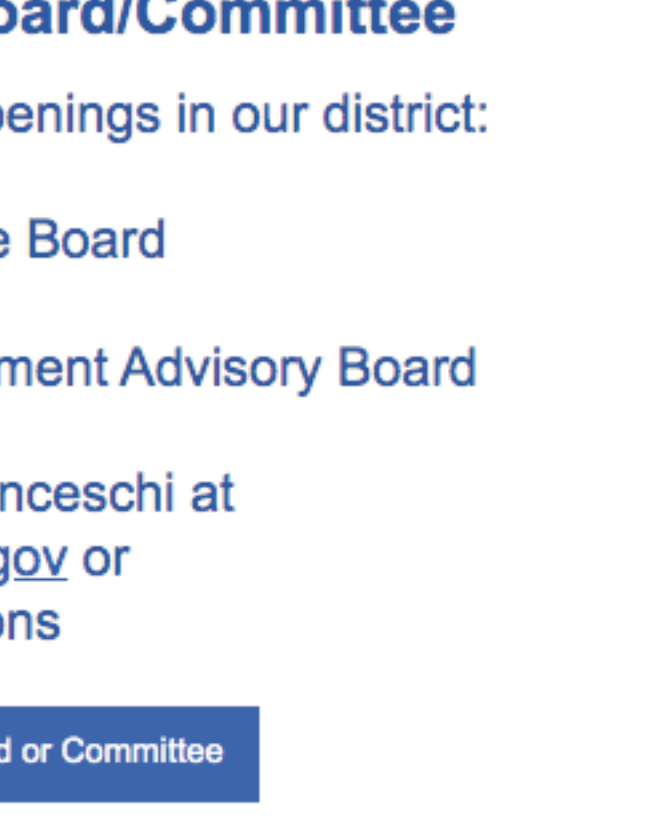

Re: 2022 City Commission Priorities – Quarterly Progress Report (April 2022)

The annual City Commission Priorities are an important short-term component of the *Fast Forward Fort Lauderdale 2035 Vision Plan*, *Press Play Fort Lauderdale 2024 Strategic Plan*, and the annual budget process as we ensure that funding is in place to advance the priorities.

In January, the City Commission met to identify and articulate the organization's highest priorities for 2022. Four Top Priorities and six Priorities were identified. Updates to the Top Priority initiatives are provided monthly to the City Commission and the community through the *LauderTrac* newsletters (accessible online at <https://bit.ly/38gRiKu>). This memo provides the first quarterly update for the six Priorities which include Community Response and Safety, Economic Diversification, Historic Preservation, Smart Growth, Waterway Quality, and Workforce Training and Education.

Community Response and Safety

The focus of this Priority initiative is the response to community health and safety, including the enforcement of code violations and vacation rental regulations, construction of the Police Headquarters, and the provision of COVID-19 testing. Emergency response, for both Fire Rescue and Police assistance, will remain a fundamental aspect of this initiative.

The City's Community Enhancement and Compliance team provides services seven days a week with daytime enforcement from 6:30 am to 6:00 pm. Nighttime enforcement is provided Thursday through Sunday from 7:00 pm to 2:00 am. As a part of this initiative, staff is evaluating resources and opportunities in the Fiscal Year 2023 budget to extend the hours of nighttime code enforcement and to promote additional enforcement of community concerns such as noise disturbances, commercial vehicles parked in residential areas at night, and vacation rentals. The City has a contract for vacation rental monitoring services and has identified 352 unregistered rentals Citywide; as of March 2022, the City had registered 1,040 rentals. While the number of unregistered rentals fluctuates based on the seasonal nature of some properties, the Community
