### Broward County's Regional Communication System (911) Update

On Tuesday, December 6, the County Commission discussed the issues with the Regional 911 system. During the discussions we confirmed that we are committed to make the necessary adaptations as recommended by the draft FITCH report. As you may recall, earlier this year the County allocated extra funding to the Broward Sheriff's Office (BSO) for the purpose of hiring additional call takers. The sheriff has advised that the vacancy rate has decreased dramatically, and that the newly hired call takers are going through a rigorous training process. The draft FITCH report provides for areas of improvement and our staff are in the process of implementing these recommendations. My colleagues, administration and I are fully committed to working with BSO to enhance the regional system and enhance public safety.

## Fort Lauderdale International Airport (FLL) Update and Traveling Tips

FLL passenger traffic is nearing pre-pandemic levels. This month, Norse Atlantic Airways added nonstop service between FLL and Berlin, Germany. New dining and shopping options also opened earlier this year, including the Kona Big Wave Bar in Terminal 1 and 3Sixty Duty Free & More in Terminal 3. Additionally, you might hear a friendly voice over

the speaker when walking through FLL. As I assumed my mayoral duties earlier this month, I was able to record the Airport message for travelers and visitors. A tremendous thank you to Mr. Alfonso Walker, a Broward County Aviation Department (BCAD) employee and veteran, who assisted me in the recording process.



If you are flying, BCAD encourages travelers and visitors to be prepared this holiday season. Roads, parking, valet services and the airport itself will receive an influx of visitors this month. FLL recommends travelers (1) make contingency plans for getting to/from airport, (2) allow more time to complete check-in and security screening, (3) arrive at least 2 hours before domestic flights or 3 hours for international flights, and most importantly (4) pack your patience and be kind. # **Port Everglades Update**



Port Everglades cargo volumes fell one day short of breaking its own annual record by just 919 containers! Although the Port did not break its own record, we are still proud of the successes we have been able to make this year. Port Everglades moved a total of 1,107,546 TEUs (20-foot equivalent units, the standard measurement for container volumes) in FY2022, up 7% from FY2021. The

Port's energy sector also celebrated its second-best year, with a 12% increase in petroleum volumes. A near record of 126,502,464 barrels of petroleum (5.3 billion gallons), mostly gasoline, diesel and jet fuel, were distributed by the privately owned energy companies that operate from Port Everglades.

Additionally, the Port was recently awarded a \$19 million federal grant by the U.S. Department of Transportation under the Port Infrastructure Development Program, to modernize several cargo docks and ensure efficient operations over the next 75 years. This is the Port's first large federal infrastructure grant award in recent history. For more news about Port Everglades, visit Porteverglades.net.
