

Minutes of GMCA Advisory Board Meeting Thursday, June 20, 2024, 11:00 AM - Cafe Vico

Prior to the meeting at 11:00 a.m. at Cafe Vico, at 10:15 a.m. the plaque for Eric Berkowitz was unveiled on the street bench at 3800 Galt Ocean Drive. Remarks were made by Broward Commissioner Lamar Fisher, Ellyn Bogdanoff, Eileen Bendis and Fred Nesbitt.

Galt Mile CPR/AED Training

- Assistant Fire Chief Gregory May explained the importance of and showed how to use Narcan nasal sprays available for individuals having a Fentanyl overdose. All buildings should have Narcan sprays available; which is available from the Fort Lauderdale Fire Rescue. He expressed appreciation to Fred Nesbitt and Cornelia Cave, Galt Mile CPR Coordinator involved in training 400 Galt Mile residents. Fred Nesbitt presented a plaque to Battalion Chief Daniel Oatmeyer, the CPR coordinator and teacher of our CPR classes. Unfortunately, Chief Oatmeyer could not attend due to fire department meetings, so Chief May was asked to deliver the plaque.
