## Port Bypass Road Update

Broward County is making great progress on the Port Bypass Road. Most recently, I alongside the city of Fort Lauderdale's Mayor took a tour of the project area. The Port Bypass Road construction began on May 1, 2024, and the overall project is about 50% complete. Most of the drainage, utility, and underground improvements were installed. The contractor made significant progress with the roadwork associated with the Bypass Road which includes barrier walls and fencing. Most of the bridge columns and caps are complete and they are now placing beams. The Bypass Road is scheduled to be opened to traffic by November 2025.

## Port Everglades Update



Port Everglades first quarter of the 2025 Fiscal year is off to a great start. The port's total container throughput in TEUs (20-foot equivalent units) is up by 12% to 285,335 TEUs compared to 255,241 from the same period in FY24. Also trending upward is petroleum as measured by the barrels that are delivered to 12 counties in Florida and five international airports.

Additionally, Port Everglades' cruise business line is on course for a buoyant fiscal year based on double-digit growth during the first quarter of Fiscal Year 2025. The wave of growth is also seen in the port's cruise passenger traffic, which is up by 27% to 1,349,313 guests versus 1,064,998 compared to the same period in FY24. The port anticipates setting a new cruise passenger record in FY25 with a forecasted 4.4 million guests, with some of the busiest months ahead. For more information, visit <u>PortEverglades.net</u>.

## Homelessness Update in Pompano Beach

Homelessness is a major concern for all municipalities in Broward County but most notably there are major areas of concerns in our most populated cities. Most recently, I would like to share an update of the great collaboration efforts being made at the North Homeless Assistance Center (NHAC) in the city of Pompano Beach to discourage congregating and loitering in the area. Earlier this month, it came to our attention that the NHAC was in dire need of some hands-on work. Broward County's Housing Options, Solutions and Support Division (HOSS-D) quickly stepped into action, coordinating a meeting which included members from Broward Addiction and Recovery Center (BARC), Broward Sheriff's Office (BSO), Broward Partnership for the Homeless, Inc. (BPHI), the Taskforce and the City of Pompano Beach. The efforts were a major success as this collaboration was able to get 30 individuals that were outside of the NHAC engaged in services, 20 individuals received a bus pass, two individuals were placed at the NHAC, two individuals were placed at the Central Homeless Assistance Center, three individuals were placed in ODS beds, one individual was referred to Elder Hope Haven (EHH), one individual was placed in a shared living unit, one individual was placed in BARC and one individual was working with BSO to reunify with their family member outside of the country.

Additionally, we worked with the city on a list of items that the team agreed would help discourage this type of activity outside of the NHAC. The city agreed to look into placing signage (encouraging donations to be brought to the NHAC and for loitering and dumping), possibly adding cement barriers to prevent cars parking to unload "donations" on the side of the road, increasing code compliance responses, license plate recognition tools (to identify who is dropping donations off) and long term, the addition of streetlights and a bus route along Blount Rd. I'm proud of our county team for taking the lead in getting all these groups together and finding solutions for those needed assistance. I would also like to thank the city of Pompano Beach for their efforts as well.
